# Subject: Plan IV Reimbursements - Course Exemptions Updated to Include Mental Health Training Courses

Effective January 1, 2014, the Commission on Peace Officer Standards and Training (POST) implemented a Budget Expenditure Reduction Plan. This 18-month plan was instituted in efforts to mitigate a \$7.8 million deficit projected from the Department of Finance (DOF) at the end of FY 2014/15 due to declining revenue into the State Penalty Assessment Fund. POST Bulletin # 2013-14 was issued on October 7, 2013 describing the following four budget reduction items:

- 1. January 1, 2014 June 30, 2015: Backfill Reimbursement will be suspended.
- 2. January 1, 2014 June 30, 2015: All contract training courses that are not mandated or that do not directly support the Basic Courses will be reduced to their FY 2012-13 expenditures.
- 3. January 1, 2014 June 30, 2015: All Plan IV reimbursement (travel, lodging, commuter lunch and per diem) will be suspended. Contract and mandated training courses are exempt from this suspension. Attachment A is a list of Plan IV courses that are exempt from this suspension.
- 4. July 1, 2014 June 30, 2015: Some POST workshops, seminars and symposia will be suspended.

On June 15, 2014, the California Legislature approved a one time allocation from the state's General Fund of \$3.2 million to be allocated for reimbursement to local agencies for Fiscal Year 2014 -15 pursuant to Penal Code Section 13523. On June 26, 2014, the POST Commission voted to approve using these funds to reinstate reimbursement for all Plan IV courses relating to mental health, crisis intervention, persons with disabilities and autism training.

Attachment A has been updated to include all courses relating to mental health training. These courses are highlighted for ease of review. Mental health training courses are reimbursable from July 1, 2014 through June 30, 2015. All other courses listed are reimbursable from January 1, 2014 through June 30, 2015.
