SYNOPSIS: It was brought to my attention that the Chancellor's Office seat on the POST Advisory Committee is unfilled, and I was asked to choose a qualified representative for this Committee. I instructed my staff to do a search within the Community Colleges using the Chancellor's Office Statewide Public Safety Advisory Committee as a venue for nominating that person.

The Committee unanimously recommended Mr. George Beitey. Mr. Beitey is the Dean of the School of Public Safety at San Diego Miramar College. He sits on the Chancellor's Statewide Public Safety Education Advisory Committee. Mr. Beitey is a retired Sheriffs Lieutenant and has been the Dean of Public Safety at Miramar College for the past six years. He holds a Master of Arts Degree in Public Administration. Additionally, Mr. Beitey is a graduate of the POST Master Instructor program.
