

14. Describe the individual's or organization's purpose and training responsibility.

The purpose of the Master Field Training Officer is to provide direct leadership to Field Training Officers and provide assistance in the development and implementation of the Field Training Program. This involves training, mentoring, and monitoring all personnel who become involved in the Field Training Program.

DUTY AREAS & JOB ACTIVITIES

- 1. Monitor, evaluate, and provide feedback on the Field Training Program. Assist in the development, and update, of the Los Angeles County Sheriff Department's Field Training Program. Attend meetings of training administrators and provide input for improving the Field Training Program. Maintain a liaison with other station operations such as Detective Bureau and Community Relations for information that may impact and benefit the Field Training Program as well as patrol operations. Mentor and ride with deputies who have completed patrol training and provide additional training and advice.
- 2. Teach job knowledge, skills, core values, and ethics.
 Assist Training Sergeants in conducting valuable training for trainees and Field Training
 Officers, as well as all patrol trained station personnel.
 Continue to serve as an active Field Training Officer as needed.
 Instill responsibility and self-discipline by communicating the importance of the Core Values, and modeling them to Field Training Officers and trainees. Instill a sense of duty to report officer misconduct and all facts relevant to such misconduct. Conduct ethics training.
- 3. Perform supervisory and administrative duties. Analyze Daily Observation Reports prepared by Field Training Officers regarding the activities of trainees. Provide station orientation to trainees. Assist in the maintenance of trainees' records. Assist the Training Sergeant with the Field Training Program as necessary. Monitor, review, and ensure that all directives and responsibilities outlined in the Training Officer's Manual and the Field Trainees' Manual are applied. Recognize and/or bring to the attention of supervisors exceptional or deficient performance by a Field Training Officer. Provide input into a system designed to be utilized by all Field Training Officers in the sharing of information throughout the County.
- 4. Provide information to non-patrol trained deputies on patrol preparedness. Attend and assist with Patrol School. Speak at Custody, Correctional, and Court Services facilities regarding patrol preparedness, specifically to those seeking an assignment at a patrol station.

15. Describe the nominee's overall achievement.

The nominee's dedication to the Department's Field Training Program aided in reconstructing the training program at Santa Clarita Vally Station. The below principles were implimented by the Master Field Training Officer and training staff to enhance the station's training program:

Discuss deficiencies with Field Training Officers or trainees to determine the causes of deficiencies and assist with implementation of remedial plans. Gather assistance in dealing with a trainee's deficiencies by discussing areas of needed improvement with other Field Training Officers. Ride with trainees and provide remedial training, documenting strengths and weaknesses, and consult with the Training Sergeant and Unit Commander for possible initiation of patrol failure procedures. Refer a trainee to Los Angeles County Sheriff's Department resources or outside resources for help with personal problems that are affecting or could affect their performance. If it is determined that a trainee has a learning disability (e.g., dyslexia), refer the trainee to the appropriate resources for assistance. Be cognizant of signs of potential fatigue or stress that may impact a trainee's performance, and refer the trainee to the appropriate resources.
