B. Approval of the Consent Calendar

MOTION – Doyle, Second – Cooke, carried unanimously to approve the Consent Calendar.

The Commission presented Ron Cottingham, President, PORAC, with a Resolution upon his retirement.

The Commission presented POST Assistant Executive Director Dick Reed with a Letter of Appreciation upon his retirement from POST on November 1, 2013.

FINANCE COMMITTEE MEETING

C. Commissioner Sobek reported on the results of the Finance Committee meeting, held on Wednesday, October 23, 2013, in Burlingame, California.

Commissioner Sobek invited Assistant Executive Director Dick Reed to make a presentation to the Commission on Consent Item B.11 as discussed at the Finance Committee meeting.

MOTION – Bui, Second – McDonnell, carried unanimously by **ROLL CALL VOTE** to approve the recommendations of the Finance Committee and staff recommendations on Item B.11.

Commissioner Sobek also called for a **ROLL CALL VOTE** on items F and G.

Item F – MOTION – Bui, Second – Cooke, carried unanimously by **ROLL CALL VOTE** to authorize the Executive Director to enter into a contract for LEDS Instructor update training in an amount not to exceed \$61,150.

Item G – MOTION – Hutchens, Second – McDonnell, carried unanimously by **ROLL CALL VOTE** to authorize the Executive Director to enter into a contract for addition AICC Instructor training presentations in an amount not to exceed \$145,998.

STANDARDS, EVALUATION AND RESEARCH BUREAU

D. Report on Changes to the Basic Courses Test Management and Security Protocols

MOTION – Sobek, Second – Wallace, carried unanimously to authorize the Executive Director to amend Commission Regulations regarding Basic Courses Test Management and Security Protocols subject to the OAL process and if no public hearing is requested the changes will be effective August 1, 2014.

E. **Report on Proposed Regulation Changes to Coroner Entry Level Training**

MOTION – Doyle, Second – Hutchens, carried unanimously to authorize the Executive Director, subject to the OAL process, to amend Commission Regulation 1005(a)(4), 1011(a)(2)(A), and 1011(a)(4)(c) to update the Coroner Entry Level Training. If not public hearing is requested the changes will be effective August 1, 2014.

G. **Report on Request to Contract for Additional AICC Presentations**

Item voted on during Finance Committee presentation to the Commission. **MOTION** – Hutchens, Second – McDonnell, carried unanimously by **ROLL CALL VOTE** to authorize the Executive Director to enter into a contract for addition AICC Instructor training presentations in an amount not to exceed \$145,998.

H. **Advisory Committee**

Jim Bock, Chair of the POST Advisory Committee, reported on the results of the Committee meeting on October 23, 2013, in Burlingame, California. Chair Bock reported the Committee reviewed the entire Commission agenda and made recommendations to approve all items. Chair Bock reported the Committee viewed a presentation by the Computer Services Bureau on the e-Student Workbooks for the Basic Courses.

No **MOTION** was heard to approve the report by the Advisory Committee.

I. Legislative Review Committee

Mike Sobek, Chair of the Legislative Review Committee, reported on the results of the Legislative Review Committee meeting held on Thursday, October 24, 2013, in Burlingame, California.

The Committee requested a motion from the Commission to authorize the Executive Director to begin developing language and pursue legislation to assist POST with personal services contracts.

MOTION – Doyle, Second – Dudley, carried unanimously to authorize the Executive Director to begin working to create legislation to assist POST with personal services contracts.

J. Correspondence

Commissioner Kurylowicz reviewed the correspondence to and from POST.

K. Old Business

Report on Request for Approval of Nominations of Members to the Advisory Committee

Commissioner Kurylowicz asked for a MOTION to approve the nominations and appoint the identified individuals to a three-year term on the Commission's Advisory Committee.

MOTION – Cooke, Second – McDonnell, carried unanimously to approve the appointment of identified individuals to a three-year term on the Commission's Advisory Committee.

Commissioner Kurylowicz asked for new business.

- R. C. Smith, Bureau Chief, Center for Leadership Development, provided a presentation on the "Building a Career Pipeline to Meet Law Enforcement Recruitment and Community Challenges". - Commissioners Sobek, Bui and Cooke addressed the Commission, and expressed thanks to the Executive Director, Commissioners past and present, POST staff, associations and supervisors for their support and hard work.

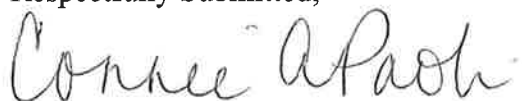
