If no public hearing is requested the changes will be effective February 1, 2017.

MANAGEMENT COUNSELING, LEADERSHIP DEVELOPMENT BUREAU

F. Report on Request to Contract for a POST Internal Organizational Study

The Commission called for a report on the agenda item. Assistant Executive Director Jan Bullard provided a report.

The Commission directed staff to pursue the contract through the Department of General Services contract process to identify an appropriate vendor. The Commission further directed staff to contact stakeholders to ascertain areas of improvement or any unmet need.

MOTION – Braziel, Second – Moore, carried by **Roll Call Vote** to authorize the Interim Executive Director to enter into a contract with an entity to conduct a stakeholder survey to identify systems and practices and then develop a scope of work to be brought before the Commission at its next meeting.

Legal Counsel Darden asked to revisit the Organizational Study agenda item. Mr. Darden clarified the motion as approving the Executive Director to enter into a contact with a vendor, in an amount not to exceed \$75,000 to engage in a study of POST with external stakeholders in which the finding might be used in the future, potentially, with another contract, to determine organizational changes.

MOTION – Braziel, Second – Doyle, carried by Roll Call Vote to authorize the Interim Executive Director to enter in a contract with an entity to in an amount not to exceed \$75,000 to engage in a study of POST with external stakeholders in which the finding might be used in the future, potentially, with another contract, to determine organizational changes.

The Commission agreed that Commissioner Braziel will act as an advisor to POST staff in the organizational study after a vendor has been selected.

Commissioner Bui suggested staff also begin work on identifying potential vendors through the Department of General Services (DGS) process for the completion of the internal audit. The Commission agreed and no other motion was heard on this item.

Assistant Executive Director Jan Bullard asked to readdress the Commission to clarify that the Commission directed staff to approach the organizational study contract in two phases:

- Phase One: Outreach to stakeholders to ascertain areas that require improvement, and
- Phase Two: (Upon approval of Phase One) Conduct internal focus in light of the findings of Phase One.

MOTION – Braziel, Second – Chaplin, carried by **ROLL CALL VOTE**, to authorize the Interim Executive Director to enter into a contract with an appropriate entity for a two phase organizational study that will include outreach to POST's stakeholders in an amount not to exceed \$75,000.

COMMISSION APPEAL HEARINGS

K. Report on Appeal to Commission by Vikas Kurian

Commissioner Dudley called upon legal counsel for Mr. Kurian. Ms. Danielle Little of Estelle and Kennedy APLC was provided instructions regarding time limits and asked to address the Commission regarding the appeal by Mr. Vikas Kurian.

The Commission heard testimony and rebuttals from Ms. Little, Interim Executive Director Stephanie Scofield and Scott Loggins, Bureau Chief, Basic Training Bureau.

The Commission asked several questions and announced they would deliberate in Executive Closed Session and render a decision at the conclusion of Closed Session.

COMMITTEE REPORTS

L. Advisory Committee

Mario Casas, Chair of the Advisory Committee, provided a report on the results of the Advisory Committee meeting held on Wednesday, June 22, 2016, in West Sacramento, CA.

Advisory Chair Casas announced the Committee had elected a new Chair, Marcelo Blanco and Vice Chair Randy Waltz.

Commissioner Dudley called for a **MOTION** to accept the report of the Advisory Committee.

MOTION – Braziel, Second – Wallace, carried unanimously to accept the Advisory Committee report and recommendations on the New Committee Chair, Committee Vice-Chair and Commission Agenda.

M. Legislative Review Committee

Jethroe Moore, Chair of the Legislative Review Committee, provided a report on the results of the Legislative Review Committee meeting held on Thursday, June 23, 2016, in West Sacramento, CA.

Commissioner Moore announced that Commissioner Braziel has recommended the Legislative Review Committee be disbanded and the Committee members be repurposed to other causes, such as; POST Organizational Study or a Strategic Plan Committee. The Committee suggested a legislative update could be provided to the Commission as part of the regular Commission meeting agenda.

Commissioner Dudley called for a **MOTION** to accept the recommendations of the Legislative Review Committee to disband and repurpose for other causes.

MOTION – Moore, Second – Bui, carried unanimously to disband and repurpose the Legislative Review Committee effective immediately.

Commissioner Dudley called for a **MOTION** to accept the report of the Legislative Review Committee.

MOTION – Doyle, Second – Wallace, carried unanimously to accept the Legislative Review Committee report.

N. Executive Director Recruitment Advisory Committee

Joyce Dudley, Chair, Executive Director Recruitment Advisory Committee, provided an update on the Committee meeting held on June 22, 2016, in West Sacramento.

Commissioner Dudley announced the Committee met and discussed the Executive Director position and will discuss it further in Closed Session.

Commissioner Dudley called for a **MOTION** to approve the report of the Executive Director Recruitment Advisory Committee.

MOTION – Chaplin, Second – McDonnell, carried unanimously to accept the report of the Executive Director Recruitment Advisory Committee meeting.

Commissioner Dudley reviewed the correspondence to and from POST.

P. Old Business

Report on POST Screening Requirements for Retired Peace Officers Returning as Retired Annuitants

Dr. Shelley Spilberg, and Melani Singley, Personnel Selection Consultant, provided a report to the Commission.

The Commission discussed a regulatory language change allowing agencies the discretion of conducting a background investigation update on peace officers re-appointed to an agency with 180 days of voluntary separation.

The Commission moved to have Commissioner Robert Doyle appointed to implement the direction of the regulation language change regarding a 180 day break in service. The direction of the Commission was to proceed with the Office of Administrative Law process prior to the October 2016 meeting.

Commissioner Dudley called for a **MOTION** on the report under Old Business.

MOTION – Braziel, Second Smith, carried unanimously to authorize Commissioner Robert Doyle to review and approve changes to Commission regulations changes regarding reappointment requirements for Retired Annuitants and pursue the proposed changes through the Office of Administrative Law (OAL) process.

Q. <u>Nominations to Reappointment to the Advisory Committee</u>

Commissioner Dudley read the recommendations for reappointment to the Advisory Committee.

After reading all the recommendations, Commissioner Dudley call for a **MOTION** to approve all the recommended reappointments to the Advisory Committee.

MOTION – Moore, Second – Wallace to approve all recommendations for reappointment to the Advisory Committee as listed in the agenda item.

R. Nominations of Replacements to the Advisory Committee

Commissioner Dudley asked for a **MOTION** to approve Lanny Brown, President, California Academy Directors Association (CADA), as the CADA representative replacement on the POST Advisory Committee.

MOTION – Doyle, Second – Kurylowicz, carried unanimously to accept Lanny Brown as the CADA representative replacement on the Advisory Committee.

Commissioner Dudley asked for a **MOTION** to approve Jamie Young, Director, California Public Safety Dispatcher Advisory Council (CPSDAC), as the CPSDAC representative replacement on the POST Advisory Committee.

MOTION – Ramirez, Second – Braziel, carried unanimously to accept Jamie Young as the CPSDAC representative replacement on the POST Advisory Committee.

Commissioner Dudley asked for a **MOTION** to approve Artin Baron, Orange County Senior Deputy Coroner, as the California Coalition of Law Enforcement Associations (CCLEA) representative replacement on the POST Advisory Committee.

MOTION – Bui, Second – Moore, carried unanimously to accept Artin Baron as the CCLEA representative replacement on the POST Advisory Committee.

P. Nominations for New Commission Chair and Vice Chair

Commissioner Dudley announced the Commission heard in the Legislative Review Committee meeting that the Assembly and Senate approved the Governor's Trailer Bill language authorizing the Governor the power to appoint the Commission Chair.

MOTION – Moore, Second – Ramirez, carried unanimously to delay action on this agenda item at the October 2016 Commission meeting.

Commissioner Dudley called the meeting to order in open session and asked Mr. Darden to brief attendees on the items discussed in Closed Session.

Mr. Darden explained the Commission was briefed and discussed personnel issues, pending litigation matters, the Appeal of Mr. Vikas Kurian, and considered the selection process for an Interim Executive Director of POST and had two votes.

The first, after deliberation, the Commission voted to permit Mr. Kurian to take the requalification course within six months and denied payment of his attorney fees. The Chair and Mr. Darden will create the opinion that will be sent out within 15 business days. The Commission agreed that Commissioner Dudley has the authority to sign a formal letter to Mr. Kurian.

The second was the Commission decided to hold Interim Executive Director selection interviews on July 13, 2016 at POST beginning at 10:00 a.m. He said, Stephanie Scofield will be one of the individual's interviewed for the Interim Executive Director position.

Commissioner Dudley called upon Assistant Executive Director Dave Cornejo to explain some to the additional discussion held in closed session.

Mr. Cornejo explained the Commission discussed the possibility of POST certified course instructors earning training credit for teaching the course. The Commission also discussed the possibility of increasing flexibility in POST course outlines.

Commissioner Dudley explained the Commission discussed the desire to have more diversity on the Advisory Committee. The Commissioner would like more consideration be given to diversity of the Advisory Committee in 2017. They suggested informal conversation occur with the Associations represented on the Advisory Committee.
