Mr. Perez,

Thank you for your time on the Google Meet call you set up this morning at 8:00am. This email is to memorialize our conversation and confirm your verbal request that the Inglewood Unified School District Police Department be removed from the POST program. Cc'd on this email is POST Bureau Chief Jackie Nelson.

From our call, I learned that the IUSDPD currently does not have a police chief or department head and that it has only one officer remaining in its employ. This officer, [REDACTED] has submitted his intention to retire in August of this year 2021. There are no other IUSDPD employees at this time. The school district has no plans to hire any additional officers or employees and has decided to dissolve its police department when Officer [REDACTED] retires. We reviewed the IUSDPD EDI roster and concurred that it is out of date and inaccurate with the agency having no way to edit it in EDI as our belief is that Officer [REDACTED] does not have EDI access or training.

As such, it is your request as the Chief Operating Officer of the Inglewood unified School District that the Inglewood Unified School District Police Department be removed from the POST program effective immediately. We at POST are obviously sad to see you go, but understand your decision and request. As we discussed, removal from the POST program does not alleviate the District's responsibility to operate its police department within current state law and standards.

Kindly "reply all" to this email with your confirmation or corrections. If your reply confirms your request to be removed from the POST program, I will start that process with POST headquarters in West Sacramento and you will receive official correspondence and confirmation from them.

Again, thank you for your time and consideration. We at POST wish you and the Inglewood School District nothing but the best in your future endeavors.
