

AB 846 Stakeholder Interest Survey

AB 846 (2020) added Section 1031.3 to the Government Code requiring the California Commission on Peace Officer Standards and Training (POST) to, by January 1, 2022, “study, review, and update ... regulations and associated screening materials related to the emotional and mental condition evaluation required by Section 1031 to incorporate both of the following:

- (1) Identification of explicit bias towards race or ethnicity, gender, nationality, religion, disability, or sexual orientation.**
- (2) Identification of implicit bias towards race or ethnicity, gender, nationality, religion, disability, or sexual orientation. ...”**

POST has completed their study and review of the issues outlined in the legislation and has developed recommendations for implementation.
