To whom it may concern:

I would like to nominate Rich Meraz for the California Commission on Peace Officer Standards and Training's Bud Hawkins Award. Rich worked 43 years at the Los Angeles Police Department and retired as a Captain 3 in April, 2007. Even in retirement, Rich has continually enhanced professionalism in California Law Enforcement as a facilitator for the Supervisory Leadership Institute. He also decided he was obligated to share his story as one of the commanding officers of the Rampart Division of LAPD when the Rampart Scandal occurred. Rich masterfully weaves many of the SLI leadership concepts of learning outcomes when he presents to students. He strategically plants thought seeds that continue to grow as students continue their careers. Rich also presents (on request) to Police and Sheriff's Departments around the state. Last year, Rich presented to commanders and supervisors of a local Sheriff's Department, and I heard nothing but kudos from those I spoke with who attended.

Rich Meraz is almost 80 years old and continues to facilitate SLI as well as provide the Rampart Scandal learning presentation to every SLI class. He also works as a facilitator at the Simon Wiesenthal Museum of Tolerance in Los Angeles showcasing the importance of human rights and the dangers of prejudice and discrimination.
