ADDITIONAL INFORMATION THE COMMISSION SHOULD KNOW:

In FY20/21, the Supervisory contract total was \$298,150.00. Contracted presenters received only \$6900.00 reimbursement from POST for each 2-week course, requiring tuition to cover all presentation costs. All supervisory courses were moved from contract to POST Plan V in FY21/22. This allowed presenters to receive full funding for their presentations and remove the requirement to charge students tuition to cover presentation costs.

Budget issues occurred when presenters were unable to budget matching funding for staff due to constraints of POST reg. 1054. Most presenters advised the maximum rates for staff outlined in reg. 1054 were below current hourly rates paid to presenter staff. Since funding encumbered to contract is not subject to POST reg. 1054, TPS moved to contract Supervisory Course Presenters to allow for accurate staff funding, relieve agencies from tuition cost, and accurately fund presenters for actual presentation costs.

Total Supervisory contract of \$1,859,048.97 request reflects true presenter costs with the addition of five returning presenters with 28 additional presentations to accommodate an influx of supervisory promotions due to forecasted attrition among Peace Officers.
