- (a) The commission shall prepare an annual report, on behalf of the board, on the activities of the Commission, board, division, and subject agencies regarding peace officer certification pursuant to Penal Code Section 13512. The report shall include the following:
 - (1) The number of requested applications submitted for certification.
 - (2) The number of certifications granted or denied.
 - (3) The number of events reported pursuant to paragraphs (1) to (5), inclusive, of subdivision (a) of Penal Code Section 13510.9, as listed below:
 - (A) <u>The employment, appointment, or termination, or separation from employment or appointment, by that agency, of any peace officer.</u>

 <u>Separation from employment or appointment includes any involuntary termination, resignation, or retirement.</u>
 - (B) Any complaint, charge, or allegation of conduct against a peace officer employed by that agency that could render a peace officer subject to suspension or revocation of certification by the commission pursuant to Penal Code Section 13510.8.
 - (C) Any finding or recommendation by a civilian oversight entity, including a civilian review board, civilian police commission, police chief, or civilian inspector general, that a peace officer employed by that agency engaged in conduct that could render a peace officer subject to suspension or revocation of certification by the commission pursuant to Penal Code Section 13510.8.
 - (D) The final disposition of any investigation that determines a peace officer engaged in conduct that could render a peace officer subject to suspension or revocation of certification by the commission pursuant to Penal Code Section 13510.8, regardless of the discipline imposed.
 - (E) Any civil judgment or court finding against a peace officer based on conduct, or settlement of a civil claim against a peace officer or an agency based on allegations of officer conduct that could render a peace officer subject to suspension or revocation of certification by the commission pursuant to Penal Code Section 13510.8.
 - (4) The criteria and process for review and investigation by the division, the number of reviews, and the number of investigations conducted by the division.

ADOPT

- (5) The number of notices sent by the division pursuant to paragraph (1) of subdivision (a) of Penal Code Section 13510.85, the number of requests for review received, and the number of suspensions or revocations or denials made pursuant to paragraph (2) of subdivision (a) of Penal Code Section 13510.85.
- (6) The number of review hearings held by the board and Commission and the outcomes of those review hearings.
- (7) The number of administrative hearings held on suspensions or revocations and the number of suspensions or revocations resulting from those hearings.
- (8) Any cases of judicial review of Commission actions on suspension or revocation and the result of those cases.
- (9) The number of certifications voluntarily surrendered, and the number placed on inactive status.
- (10) Any compliance audits or reviews conducted, pursuant to Penal Code Sections 13500-13553, and the results of those audits.
- (b) This annual report shall be made available in a manner that is accessible to the public.
